# HARDWICK TOWNSHIP PLANNING/LAND USE BOARD FEBRUARY 13, 2020

## **REORGANIZATION:**

# **Election of Chairman**

Attorney Gavan called for nominations for Chairman. Mr. Lovell made the motion to nominate Jim McKim. Motion seconded by Mr. Hughes. Attorney Gavan asked if there were any other nominations. With there being no other nominations, the nominations were closed. In a roll call vote, all were in favor of electing Jim McKim as Chairman. Abstaining: Alt# 4 Ms. Schemm.
