# TOWNSHIP OF HARDWICK WARREN COUNTY, NEW JERSEY

# **February 1, 2017**

The monthly Business meeting of the Hardwick Township Committee was held on this date at the Municipal Building, 40 Spring Valley Road, Hardwick, New Jersey. This meeting was called to order at 6:30PM by the Township Clerk Judith Fisher who noted that this meeting was being held in compliance with the "Open Public Meetings Act":

In accordance with Chapter 231 of the Public Laws of 1975, notice of this meeting was given by way of notice with the New Jersey Herald and/or the Express-Times, filed in the Municipal Clerk's Office and posted in the Hardwick Municipal Building. Mayor Perry then led the public in the pledge of allegiance.

#### **REPORTS**

**Mr. Rodman, Township Engineer** reported that he will be applying for the NJDOT Grant again this year for the Township. The project will be for the next section of Birch Ridge Road about 1.57 miles.

The Verizon Wireless request is at the Planning Board. The Township Committee has not taken any action on this request. Mr. Rodman updated the Committee on this system. Verizon is requesting to use the Township right of way by placing cabinets on the polls to provide better service. There discussion is within the next three year to increase service from 4G to 5G. It was brought up that many of the roads in the Township are County. Next was a discussion on the driveway at 70 Birch Ridge Road which was opened without an approved application/permit. Zoning Officer has issued a violation.

**Mr. Campbell, CPWM:** reported that the roads are ok as it was a milder winter this year. He next talked about the service contract the Township has with H.T. Lyons from PA. Their maintenance agreement will expire September 1, 2017 and he is recommending that the Township not renew it. Mr. Campbell's recommendation is to go with a local contractor, C & L Company, owner Carl Brockmann, who would charge \$135.00 per hour. This would be for repairs on the furnace and air conditioning.

A motion was made by Mr. Duffy, seconded by M. Carrazzone and carried to authorize Mr. Campbell to contract with C & L Company, owner Carl Brockmann, to service the Township furnace and air conditioners at \$135.00 per hour.

# ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK 2017-01

(N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Township Committee of the Township of Hardwick in the County of Warren finds it advisable and necessary to increase its CY 2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Hardwick Township Committee hereby determines that a 3.0% increase in the budget for said year, amounting to \$ 21,517.80 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Hardwick Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Township Committee of the Township of Hardwick, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Township of Hardwick shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$ 25,104.10, and that the CY 2017 municipal budget for the Township of Hardwick be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
