Mr. Herrman reviewed his proposal with the Committee. He presented them with a new fresh look. The initial outlay and monthly maintenance was also reviewed. After doing the discovery and design, the time frame would be about 6 to 7 weeks before going live pending Committee approval.

Mr. Rodman was present to discuss Stormwater management. The Township is a Tier "B". The NJDEP permit expired in 2014, but an extension was given to 2018. The requirements for this program were briefly reviewed. The Committee will discuss it further at the next meeting.

70 Birch Ridge Road: Noted is that there has been no Certificate of Occupancy or driveway permit issued.

Hardwick House: No change in their status.

Raises: The Township attorney and Township Engineer will both be receiving a 3% raise for this year. The Mayor noted that it has been several year since this was done.
