REPORTS

Mr. Rodman, Township Engineer: reported that there will be a pre-construction meeting with the Count regarding the paving of Route 521 next week. This project should be finished by May 14th. He also discussed the Stormwater Management plan and the need for a coordinator. He has someone in mind that would work on this for time and material. Next week he will be meeting with the Zoning Officer, George Boesze for a site inspection at the home on Birch Ridge Road.

Mr. Campbell, CPWM: stated that he had an inquiry on the old rubber tire roller that has been sitting in the backyard for some time. Mr. Frank VanHorn was interested in the Township donating it for the Warren County Fair. They will come with a trailer to pick it up. The Committee agreed to donate this 1963 Gallion rubber tire roller to them. Mr. Lavery asked Tom to provide me with a description and serial number so that he can do the resolution for next meeting.

Mrs. Christine Rolef, CFO: let the Committee know that next month she will have a resolution to authorizing the cancelling of the balances in the General Capital Appropriations Ordinance 2014-05. According to the Auditor, this must be done prior to the 2nd reading and public hearing for the 2017 Municipal Budget, which is scheduled for the April 5th meeting.

Mr. Lavery, Twp. Attorney let the Committee know that he had a call from BPU regarding the Concord Energy Co-op contract. He will check with the Attorney for Fredon Township.

Mrs. Fisher, Twp. Clerk review correspondence

The Clerk received a memo from the Planning Board regarding to the Boy Scouts of America application that was incorrectly sent to the Tax Assessor David Gill. They are seeking a site plan approval for a new Trading Post. This was discussed and the Committee will grant a waiver.

A motion was made by Mr. Carrazzone, seconded by Mr. Duffy and carried to acknowledge that the Certified Notice for the above was incorrectly sent to the Hardwick Township Tax Assessor David Gill in error. After reviewing this information, the Hardwick Township Committee has granted a waiver of the 10 day required notification so that the Planning Board can go ahead with the hearing on March 9th. A voice vote was unanimous.

Mr. Duffy spoke about this topic noted that he has done a lot of research on the Companies out there. City Connect who does the League web is interested in sending a proposal for Hardwick. They are local and Mr. Duffy has invited them to our next Work Meeting, March 15th. After listening to their proposal, Mr. Duffy is hoping that the Committee can make a decision then.

2017-17 AUTHORIZING EXECUTION OF AN AGREEMENT WITH THE MORRIS COUNTY COOPERATIVE PRICING TO RENEW MEMBERSHIP THEREIN FOR THE PERIOD OF OCTOBER 1, 2016 THROUGH SEPTEMBER 20, 2021

WHEREAS, the Morris County Cooperative Pricing Council ("MCCPC") was created in 1974 to conduct a voluntary cooperative pricing system with municipalities, board of education, and other public bodies located in the County of Morris and adjoining counties; and

WHEREAS, the purpose of the MCCPC is to provide substantial savings on various goods and services to its members through the cooperative public bidding process; and WHEREAS, the Township of Hardwick desires to enter into an Agreement with the MCCPC, which is administered by Randolph Township as Lead Agency, to renew its membership in the MCCPC for the period of October 1, 2016 through September 30, 2021.

BE IT RESOLVED, by the Township of Hardwick, County of Warren, State of New Jersey as follows:

- 1. Township Committee of the Township of Hardwick hereby authorize the execution of an Agreement with the Morris County Cooperative Pricing Council by the Township of Randolph as Lean Agency dated October 1, 2016 pursuant to N.J.S.A. 40A:11-11(5). Said Agreement is for renewal of membership in the MCCPC for a five (5) year period from October 1, 2016 through September 30, 2021.
- 2. The Hardwick Township Clerk is hereby directed to submit a copy of this Resolution, along with an executed Agreement, to Randolph Township Lead Agency of the MCCPC
- 3. This Resolution shall take effect immediate upon final passage according to law

4. All appropriate Hardwick Township Officials are authorized and directed to perform all required acts to affect the purpose of this Resolution
