Mr. Rodman, Township Engineer discussed changes to the Driveway Ordinance. A memo was sent to the Attorney noting several other changes that he is recommending at this time. Mr. Lavery will incorporate they in the draft Driveway Ordinance. Stormwater Management is being worked on through his office with the help of his secretary Sarah.

Mr. Campbell, CPWM, reported that Paulinskill Road has been completed. The new loader has been ordered and he discussed placing the old one on the Municipal Bid site. If the Township were to trade the old loader in, they were offer \$17,500. Tom's feels that if the Township places it on the Municipal Bid, we might be able to get more. After a brief discussion, a motion was made by Mr. Carrazzone, seconded by Mr. Duffy and carried to place the old loader on the Municipal Bid with a minimum bid price of \$25,000. Mr. Campbell will work with the Clerk on getting the loader listed on the Municipal Bid.

The overlay for Primrose has been completed. The Township did not receive DOT Grant funding for Primrose Road this year, but the Engineer will look into submitting for discretionary fund from the state.

Ms. Jackie Espinoza, representative from JCP&L was present to talk to the Committee about an event that will be taking place this Saturday at the Beach. She was also checking in to see that things were no problems that she should be made aware of.

Mrs. Christine Rolef, CFO: reviewed the monthly finance report along with the current bill list. She also reported that the Bond was renewed at Lakeland Bank for 1.87% and that there is a resolution on the agenda tonight for approval.

Mr. Lavery, Twp. Attorney: Nothing new to report on at this time

Mr. Bob Wolff, Retired Fire Warden: noted that the Fire Tower was up and operating.

Mr. John Lovell, Grants Coordinator: was not present tonight

2017-30 RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HARDWICK, IN THE COUNTY OF WARREN, NEW JERSEY, COVENANTING TO COMPLY WITH THE PROVISIONS OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, APPLICABLE TO THE EXCLUSION FROM GROSS INCOME FOR FEDERAL INCOME TAX PURPOSES OF INTEREST ON OBLIGATIONS ISSUED BY THE TOWNSHIP OF HARDWICK AND AUTHORIZING THE MAYOR, TOWNSHIP CLERK, CHIEF FINANCIAL OFFICER, AND OTHER TOWNSHIP OFFICIALS TO TAKE SUCH ACTION AS THEY MAY DEEM NECESSARY OR ADVISABLE TO EFFECT SUCH COMPLIANCE AND DESIGNATING A \$420,000 BOND ANTICIPATION NOTE, DATED JULY 7, 2017, PAYABLE MAY 1, 2018, AS A "QUALIFIED TAX-EXEMPT OBLIGATION" PURSUANT TO SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED.

WHEREAS, the Township of Hardwick, in the County of Warren, New Jersey (the "Township") from time to time issues bonds, notes and other obligations the interest on which is excluded from gross income for Federal income tax purposes and desires to take such action as may be necessary or advisable to establish and maintain such exclusion; and

WHEREAS, the Internal Revenue Code of 1986, as amended (the "Code"), contains provisions with respect to the exclusion from gross income for Federal income tax purposes of interest on obligations, including provisions, among others, which require issuers of tax-exempt obligations, such as the Township to account for and rebate certain arbitrage earnings to the United States Treasury and to take other action to establish and maintain such Federal tax exclusion; and

WHEREAS, the Township desires to designate a \$420,000 Bond Anticipation Note, dated July 7, 2017, payable May 1, 2018 (the "Note"), as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Code;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hardwick, in the County of Warren, New Jersey, as follows:

SECTION 1. The Township Committee hereby covenants on behalf of the Township, to the extent permitted by the Constitution and the laws of the State of New Jersey, to do and perform all acts and things permitted by law and necessary to assure that interest paid on bonds, notes or other obligations it issues (including the Note) be and remain excluded from gross income of the owners thereof for Federal income tax purposes pursuant to Section 103 of the Code.

<u>SECTION 2</u>. The Mayor, Township Clerk, Chief Financial Officer, and the other officials of the Township are hereby authorized and directed to take such action, make such representations and give such assurances as they may deem necessary or advisable to effect compliance with the Code.

<u>SECTION 3</u>. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.

SECTION 4. It is hereby determined and stated that (1) the Note is not a "private activity bond" as defined in the Code and (2) the Township and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2017.

<u>SECTION 5</u>. It is further determined and stated that the Township has not, as of the date hereof, issued any tax-exempt obligations (other than the Note) during the calendar year 2017.

<u>SECTION 6</u>. The Township will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code;

however, said Township does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

SECTION 7. The issuing officers of the Township are hereby authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2017 dated as of the date of delivery of the Note.

SECTION 8. This resolution shall take effect immediately upon its adoption.
