# HARDWICK TOWNSHIP LAND USE/PLANNING BOARD NOVEMBER 9, 2017

There was the regular meeting of the Hardwick Township Land Use/Planning Board on Thursday, November 9, 2017. The meeting was called to order at 7:34 p.m. by Chairman Walter Ribitzki. #### MINUTES APPROVED:

Copies of the minutes of the meeting of October 12, 2017, were distributed to all Board Members prior to the meeting.

Mr. Lovell made the motion to approve the minutes. Motion seconded by Mr. McKim. In a roll call vote, all were in favor, except for Mayor Perry and Mr. Duffy, who abstained.

## **MEMORIALIZING RESOLUTIONS:**

#### #17-004 John McNichol, Block 203, Lots 3 & 5

Mr. Lovell and Mr. McKim noted two minor corrections. Board Secretary Schemm stated that she has noted the modifications and will advise Board Attorney Gavan.

Mr. Lovell made the motion to adopt the Resolution as amended. Motion seconded by Mr. Ohl. In a roll call vote, all were in favor, except for Mr. Duffy and Mayor Perry, abstained

Mayor Perry reviewed the local Mayor's discussion in regards to the Internet meetings. He reviewed the current internet infrastructure and the upgrades in equipment and internet speed. He stated that the Township now has a Centurylink Representative. The Board then went on to discuss the different services, packages, and rates. Mayor Perry said that there are still some questions in regards to Centrylink billing. He also noted the lack of any discussion with Service Electric. He stated that he can email, to Board Secretary Schemm, the current Verizon node locations.
