Meeting was called to order by Chairman McKim at 7:35 pm.

NEW BUSINESS:

Open Space and Recreation Plan discussion

Chairman McKim stated that the Open Space Advisory Committee made three significant edits to the OSRP that was received from the consultants in March of 2023. Chapters 2 and 5 were completely rewritten and a note was added to page 9 in Chapter 1 to address concerns regarding language stating that all of Hardwick was designated as Core habitat by the NJDEP. The OSAC had already rewritten Chapter 5 at that time, but because the plan was submitted in PDF format, editing by the committee itself was thought impossible and possibly inappropriate given the role assigned to the consultants. While waiting to see if it would be possible to reengage with the consultants, the OSAC went ahead and rewrote Chapter 2, an effort previously thought desirable, but set aside at the time in the interest of speeding work along. Lack of progress eventually led the OSAC to take on a difficult, but ultimately successful effort to make the desired edits resulting in the revised April 2024 plan as now submitted to the LUB.

Chairman McKim also noted that the OSAC was unanimous both in finding the OSRP unacceptable as received and in agreeing that the rewritten April 2024 version addressed its concerns and should be forwarded to the LUB for review, comment, and adoption.

Documents had been provided to the Board prior to tonight's meeting with explanations of the changes. Chairman McKim explained the change that made to chapter one was a note on core habitat in which he proceeded to explain what that meant for the township and suggested more materials for the Board to read.

No action was taken on the Open Space and Recreation Plan and further discussion will take place at the next meeting.
