# TOWNSHIP OF HARDWICK COMMITTEE MEETING MINUTES WEDNESDAY SEPTEMBER 18, 2024

The committee agreed to utilize the remaining funds for a lift for the garage and a bay off the salt shed for storage as long as it follows the finance laws.
